## CUSTOMER HIGH SPEED DATA ONLY SERVICE AGREEMENT

High speed Internet access is always connected to our Internet Backbone (no dialing required). The high speed connection is *always on* and available (as long as your computer is on), not shared with other users and also free from over time charges. It is perfect for personal web surfing or setting up your own Internet servers.

The undersigned ("Customer") has agreed to subscribe to data Internet Service from North Dakota Telephone Company ("NDTC").

**Security/Firewall Issues:** Customer acknowledges that there are certain security issues that exist in any data network. If Customer has not installed a firewall between it and other data users on the NDTC system, there is a risk that other users on NDTC's data network, and/or, anybody on the World Wide Internet, may wrongfully or inadvertently access Customer's electronic contents. NDTC has no control over the actions of third parties and therefore makes no warranties that such activities will not occur. **In simple terms, if a firewall is not properly used, anybody anywhere in the world may observe or change what is on any computer(s) attached to the Internet. NDTC strongly recommends that all customers connecting computers or network systems to the Internet or other systems use a firewall as the minimum step in securing their information.**

Customer agrees and warrants that it will not wrongfully access any other NDTC data customer's electronic contents. In the event of Customer's breach of this duty, Customer agrees to indemnify and hold harmless NDTC for any claims, costs, or expenses arising out of such wrongful activity. Any breach of this obligation will subject the responsible individual to damages to the data customer whose rights have been violated, and may constitute grounds for criminal prosecution.

Lifeline and security services are not recommended to be used on or in conjunction with high speed services as the availability and quality of service cannot be guaranteed.

**NDTC may terminate any individual or suspend any member's access to all or any part of the service without notice for conduct that NDTC believes is a violation of this agreement or any policies or guidelines posted by NDTC on the service or for other conduct that NDTC believes harmful to others.**

Customer agrees to hold NDTC, their subsidiaries, officers, directors, agents and any of the members harmless from any liability arising from special, indirect, or consequential damages including but not limited to lost profits, loss of opportunity of any other loss which may result from the use of, misuse of, or lack of availability of NDTC or their facilities.

All high speed connects and reconnects are subject to a credit history check. A deposit may be required upon evaluation.

Operating system disks (i.e. Windows XP) must be present with each computer, or the technicians will not be able to install the Ethernet cards.

**Internet Equipment Ownership:** The high speed internet equipment will remain the property of NDTC and must be returned to NDTC in good working order when service is terminated, or a charge will be incurred.

Customer agrees it is their responsibility to make sure their computer(s) are free of viruses and/or spyware before installation of the high speed internet service.

**Other Systems:**

- ~ Macintosh systems may be supported by the help desk if the OS is current.

**On all High Speed Internet promotional services, customer will be required to maintain uninterrupted service for a period of six (6) months. At the time this contract is being signed, the Installation fee (and Federal Universal Service Charge) is being waived under the condition that high speed service is continued for the time period of six (6) months. If services are discontinued before six (6) months, the customer will be billed a \$25 termination fee and Federal Universal Service Charge.**

Installation cost of networking hardware such as switches, router/firewalls, patch panels and/or network cabling systems with category 5 wires will be billed at \$58.00/hour with a minimum of 1/2 hour. Material costs will depend on the customer's particular equipment needs. Configuration of networks and configuration & installation of Ethernet cards will be billed at \$75.00/hour with a minimum of 1/2 hour.
